- All community health center staff members are eligible for the employee awards.
- Past awardees in a specific category are not precluded from being recognized in a different category
- The award review committee reserves the right to move nominees into other categories if appropriate.
- There is no limit on the number of nominations from a health center, however, no more than one individual from a health center will be selected during the process, thereby allowing for more health center recognition during the event.

All League members and community health center staff and boards of directors are encouraged to submit nominations. Feel free to forward this correspondence to other staff or board members who may not have received it or to print out additional forms if necessary.

The deadline for submitting nominations is Thursday, January 31, 2019. Nomination forms received after that date will not be considered. ## OUTSTANDING MASSACHUSETTS COMMUNITY HEALTH CENTER:

### CLINICIAN AWARDS (2)

---

A nominee must have worked as a clinician – a licensed independent practitioner who independently provides care and treatment plans for his or her patients – in a community health center for at least five years. Nominees must have demonstrated consistent support of, and devotion to, the delivery of community health services through his or her clinical practice

### EXECUTIVE DIRECTOR/CEO AWARD

---

This award was established for the purpose of recognizing a remarkable individual as a leader who has made a considerable contribution to the community health center network. Nominees must have demonstrated a level of excellence in their leadership ability, advocacy, and organizational skills, which set them apart in a distinctive manner. A nominee must be an Executive Director of a member community health center for at least five years.

### EMPLOYEE AWARDS (2)

---

Candidacy for this award is open to all categories of employees who have worked in a community health center for at least 5 years. A nominee should exemplify, through his or her work, the professional excellence, the commitment, and the compassion, which are representative of the community health center network and its delivery of health care services.

### JOSEPH M. SMITH BOARD MEMBER AWARD

---

The Joseph M. Smith Board Member Award was established in honor of the late Joseph M. Smith who served on the League's Board of Directors and was an avid supporter of the community health center movement in Boston. This award is presented to an individual who exemplifies a high level of interest in, dedication to, and support of the delivery of primary health care services and the communities in which these services are provided.

Nominees for this award must have demonstrated a distinctive level of leadership, ombudsmanship, and advocacy, and must be, or have been, a board member of a community health center that is a member of the Massachusetts League of Community Health Centers. Board members who are patients of a health center are preferred but not required.

### EDWARD M. KENNEDY FOUNDER AWARD

---

The Edward M. Kennedy Founder Award was established in reverence to the late United States Senator, who, over the course of his esteemed career, was recognized as the nation's chief congressional advocate and supporter of community health centers. This award is to be presented annually in honor of the achievements made by dedicated consumers, administrators, clinicians and leaders who continue to protect and promote health care access as a right for all rather than a privilege for a few.

In bestowing this most prestigious award, the Massachusetts League of Community Health Centers seeks to recognize an individual who has rendered outstanding service to the community health center network, as did Dr. H. Jack Geiger, one of the founders of the first two community health centers in the nation, and Kathleen Crampton, a community activist and co-founder of the League who provided assistance to the consumers and community individuals who worked to create our state association.

Nominees will be judged on the basis of their demonstrated actions, leadership or advocacy. A nominee for this award must have been actively involved, directly or indirectly, with the development or delivery of community health care services over a period of at least 10 years. but is *not required* to be a founder of a community health center.
